DHA has shelter space for approximately 120 cats and 50 dogs. DHA provides care for these animals while trying to find them permanent homes through adoption by members of the community. In 2017, 817 dogs and 754 cats were successfully adopted.

Spay/Neuter Services:

DHA spays and neuters all animals prior to adoption. If needed, these services are offered to members of the community at a low cost.
